



CORPORATE MEMBERSHIP AGREEMENT

THIS AGREEMENT made and entered into this ____ day of _____, 20__ by _____, herein referred to as "Member." In consideration of the sum of \$_____, receipt of which is hereby acknowledged by Pleasant Valley Hunting Preserve, herein referred to as "Preserve," and the mutual covenants contained herein, the parties agree as follows:

1. PRESERVE shall sell to MEMBER and MEMBER shall purchase from PRESERVE a membership for game bird hunting and recreational access at PRESERVE, which membership shall be subject to all the terms and conditions contained herein.
2. The hunting season shall commence on September 1 and terminate the following March 31st of each year. However, the hunting season shall be subject to change as required by governmental regulations, field or bird conditions, or other conditions as deemed necessary by the PRESERVE.
3. MEMBER shall be issued a copy of the membership contract, which shall be valid so long as MEMBER complies with the terms and conditions of the contract, such rules, regulations, and procedures provided for herein and remains a member. Membership shall not be transferable.
4. MEMBER agrees to pay for all birds released and/or shot each day for member and their guests at such a per-bird rate, or package hunting rate if guides/dogs are provided, as established by PRESERVE. In addition, MEMBER agrees to renew their membership annually for the sum of \$ 400 payable by May 1st for the following season. The full amount is a membership due. MEMBER must abide by minimum number of birds to be released per hunt as established by the PRESERVE each season. Birds must be shot upon the day of release. If the dues of \$ 400 is not received membership shall be terminated. Membership dues may change from time to time as deemed necessary by the Preserve.
5. MEMBER may bring guests but shall be responsible for the conduct of said guests. MEMBER shall be responsible for payment of guests, and shall indemnify PRESERVE and its officers, agents, and employees for any liability arising from said guests.
6. MEMBER shall schedule hunts at least one day in advance. Hunting access is subject to availability and members are encouraged to plan ahead. MEMBER shall check in at PRESERVE clubhouse before hunting and check out at the conclusion of each hunt.
7. MEMBER and guests shall comply with such rules, regulations, policy changes, and procedures as shall be adopted and published by PRESERVE.
8. MEMBER hereby releases PRESERVE and its officers, agents, and employees from any claim of liability arising in any way from MEMBER'S use of PRESERVE.

9. PRESERVE shall have the right at any time to cancel the membership of MEMBER if such membership, in the sole discretion of PRESERVE is deemed undesirable.

10. MEMBER understands, acknowledges and agrees that hunting and recreation on or near a hunting preserve is voluntary and involves inherent risks of physical injury, including but not limited to broken bones, sprains, bruises, concussions, paralysis and even death, and expressly assumes all such risks. Such risks are inherent with hunting and outdoor recreation activities and may not be anticipated, controlled, or eliminated by the PRESERVE. The Member acknowledges that he/or she is solely responsible for any hospital, medical, rescue or treatment costs arising out of personal injury to them self or their guests while participating in activities at the PRESERVE.

11. The MEMBER is aware that the Pleasant Valley Hunting Preserve is managed by a long-term leaseholder, and the management group of the PRESERVE is not the owner of the preserve. The MEMBER will always conduct them self in way as to not jeopardize the PRESERVE management's long-term lease with the owner.
